The Coastal CODE provides grants to organizations and activities that promote the health of the Ocean and the waterways that lead to it, the Coastal CODE Fund grants money to projects that promote:

- Beach, Lake or Waterway Cleanup Activities
- Water Habitat Restoration

Who May Apply:

- USA established Public Charities (including 501(c) 3 designated organizations)
- Projects or Campaigns with a designated non-profit fiscal sponsor
- Other Organizations or individuals with a demonstrable charitable purpose (special cases)

The Coastal CODE will not fund:

- Projects outside the U.S.
- Grant requests that do not respect cultural integrity, especially of indigenous peoples
- Grant requests that do not respect responsible use of natural resources
- Litigation, endowments, capital campaigns or land acquisition
- Requests for overhead or infrastructure costs
- Activities that involve youth community members

Proposals must be short and include the following:

A project or program summary, not to exceed four pages, detailing:

- History of the organization;
- Description of the project, goals, objectives and provisions for;
- Total organizational budget, detailed project/program budget including use of TOE grant;
- Other sources of funding and collaborating organizations;
- Expected outcomes and completion date;
- A copy of the organization's (or its fiscal sponsor's) proof of non-profit status (except under special circumstances).

Coastal CODE Selection and Reporting

Selection:

The Coastal CODE Advisory Committee chooses a select group of non-profits to work with each year. The Committee meets once a year to make granting decisions. The proposal deadline to be qualified for the coming year's partnership is September 30.

Reporting:

Upon completion, grant applicants should submit a summary of the project or event, including:

- Total volunteers/participants;
- Total amount of litter/debris removed and disposal methods (landfill, recycling, etc.);
- And/or restoration activities completed, detailing purpose or expected results;
- Relevant receipts, invoices or other documentation;
- A W-9 form.

Optional submissions:

Upon completion, grant applicants are invited to submit:

- Photos of the project or event;
- Video of project or event;
- Testimonials from staff or volunteers about working with Alaskan Brewing/Coastal CODE.
